Vendors may NOT sell tickets for a raffle; only food or merchandise may be sold. Booth space is assigned on a first come basis and no refunds will be made.

Food & Drink: If selling food & drinks, you must have a State of Oregon “Temporary Food License” on location and available if necessary. Contact Julie at Crook County Environmental Health at (541) 447-8155 for permit information Vendor is responsible for obtaining proper license(s)/permit(s). Crook County Rodders and Crook County Fairgrounds are not liable for unlicensed vendors. No alcohol is permitted to be sold or consumed.

Booth Space: Vendors are responsible for their own tables, canopies and any other equipment needed as well as setting up and tearing down their booth. Vendors are responsible for protecting their own booths, cleaning up around space and removal of trash for their unit. **All canopies must be securely anchored or you will have to remove it.**
